REGULATION

on holding XVI World Championship among men and VII World Championship among women in fire and rescue (fire-applied) sport «Karaganda - 2021»

1. Goals and objectives of the competitions

XVI World Championship among men and VII World Championship among women in fire and rescue (fire-applied) sport (further – Competitions) is aimed at:

- further development and popularization of the profession of firefighters and rescuers;
- improvement of professional and sportsmanship of workers in fire and rescue services;
- strengthening friendly relations and cooperation between fire and rescue services in different countries;
- popularization and development in fire and rescue sport among the population of different states.

2. Organization of the competitions

The General management and organization of the competition is carried out by the International Sport Federation of Firefighters and Rescuers in cooperation with the Ministry for Emergency Situations of the Republic of Kazakhstan and the Akimat of the Karaganda Region. The direct organization and conduct of competitions (preparation of the competition places, transfer of the participants from the airport to the hotel and back, medical service, provision of the sports and technical equipment, catering services and accommodation, cultural program, publicity in the mass media, etc.) is carried out by the Ministry for Emergency Situations with the Ministries of the national economy, finance, culture and sports, foreign affairs, the Akimat of the Karaganda region and the Public Association «Sport Federation of Firefighters and Rescuers».

Competitions are held in accordance with the rules of competition in fire-rescue (fire-applied) sport and the Rules of international competitions in fire and rescue sport with the additions and changes in 2021.

The fire and technical equipment (with photo), which apply in combat deployment and fire relay race, should be published on the website www.interfiresport.com not later than June 25th, 2021.

The competitions are held in the combat deployment of the motor pumps of the company «ROSENBAUER FOX III» with connecting hoses STORZ.

3. Timelines and venue of the competitions

The competitions will take place: from August 31st to September 6th, 2021.

The venue of the competitions: Karaganda city (the Republic of Kazakhstan).

4. Participants and conditions of admission

The national men and women's teams of the member-countries of the International Sport Federation of Firefighters and Rescuers, as well as countries received an invitation, take part in the competitions.

The composition of sport delegations-33 persons: head of delegation -1, representative of team -2, coach -2, doctor -2, referee-2, press -2, interpreter -2, athletes: men -10, women -10.

It is allowed to change the quantitative structure of delegation taking into account the declared athletes and the sports personnel.

The representatives of teams need to submit to credentials committee the signed request and passport (or identity card). The athletes for competitions are not allowed without these documents. The request should be separate for men and women.

The doping control will carry out among men and women during the competition in accordance with the provisions of the World Anti-Doping Code (WADA), International testing standards and Prohibited list. The order of collecting samples is determined at the joint meeting of team's representatives and the Panel of Referees **September 1st, 2021.**

Competitions in climbing with the hook ladder, overcoming the 100-meter obstacle course, combat deployment carried out on two attempts.

^{*} The awarding ceremony of winners by species can be carried out during of the competitions or on the closing day of the competition.

7. Procedure and conditions of defining the team and individual championships

Overall team championship is determined on the basis of the least amount of places, taken by teams in all the sports events. In case of equality in total places, the higher place is awarded to the team having best result in the combat deployment.

Team championship in the sports events is determined on the basis of minimum total time. In case of time equality, the teams are awarded the same place (subsequent place is not awarded).

The team, which has not total number of scores, is awarded a place after the teams having full score. In case of equality of incomplete scores, the team is awarded a place to the team having the minimum score time.

Individual championship in sports events including combat deployment is determined according to the best result from two attempts. In case of results equality – according to the best total time of two attempts, and in case of equality amounts of time two attempts – according to the best result of the first attempt, further – athletes who started earlier. In the case of equal results in the fire relay highest place is awarded to the team which started earlier.

Double-event does not include in team result.

To determine winners in climbing with the hook ladder and overcoming 100-meters obstacle course is held semifinal and final race. The number of athletes in final and semifinal races is determined by the number of racetracks. The results of final and semifinal races do not include in team result.

Semifinal races are formed by the results of preliminary races as follows: 1st semifinal race -5, 1, 4 and 8 results; 2nd semifinal race -6, 2, 3 and 7. Final race is formed by the results of semifinal races as follows: 3, 1, 2 and 4.

Team and individual championship among men and women in sports disciplines is performed separately.

8. Awarding

The teams, which occupy 1st, 2nd, and 3rd places, are awarded with cups and certificates; and participants – with medals and gifts.

The teams, which occupy 1st, 2nd, and 3rd places in fire relay race in and combat deployment, are awarded with cups and certificates; and participants – with medals, certificates and gifts.

The participants, who occupy 1st, 2nd, and 3rd places in individual championship in climbing with the hook ladder, overcoming 100-meter obstacle course and double-event, are awarded with medals, certificates and gifts.

Winners in sports events are awarded with champion ribbons.

The Coaches of the national teams in all the sports disciplines are awarded with medals, certificates and gifts.

9. Participation conditions of the sports delegations and participants of the competitions

The annual membership fee 3300 (three thousand three hundred) US dollars is transferred to the International Sport Federation of Firefighters and Rescuers **before** April 1st, 2021.

The participation fee 210 (two hundred ten) US dollars for one member of the sports delegation is transferred to the account of the host country before July 31th, 2021 or on the day of arrival to the competition.

The expenses, related to business trip of the sports delegations (travel tickets, accommodation, food, daily allowances during travel, salary preservation, etc.), are to be borne by the countries, sending delegation to the competitions.

The expenses, related to organization and conduction of competitions are the organizer's responsibility on account of own and involved means in accordance with the legislation.

The team which failed to pay the membership fee to ISFFR is not allowed to take part in competition (2 Regulation).

10. Procedure and time frames for requests

Preliminary application (official letter) on participation and quantitative members of sports delegation should be sent **before June 30th, 2021.**

Application form for participation of team in the competitions in sports disciplines must be provided to the credentials committee in the day of drawing lots **September 1st, 2021.**

The standard registration form must be provided before July 31th, 2021.

This information will be used by the organizer for a meeting/departure, reservations and hotel accommodation, training of accreditation badges and other issues.
