About assignment of sports ranks «International Judge» in fire and rescue (fire-applied) sport

Guided by the Regulation on the qualification category «International Judge» in fire and rescue (fire-applied) sport, approved by Resolution of the XVI International Conference of International Association «The International Sport Federation of Firefighters and Rescuers» from November 19, 2015 No. 14, subject to the execution of judicial duties in the compositions of the main jury of the World Championships and international competitions in fire and rescue (fire-applied) sport, included in the annual Plan of major sports events ISFFR and on the basis of individual record cards of the practice of judging the competition, XXII International conference of International Association «The International Sport Federation of Firefighters and Rescuers» has decided:

- 1. Assign the highest qualification category of sports judges in fire and rescue (fire-applied) «International Referee» the following nominees:
