**RESOLUTION**

**Report on the International sports activities  
and results of the ISFFR for the period 2019-2022  
and tasks for 2023-2026**

According to the statutory activities of International Association "International Sport Federation of Firefighters and Rescuers", pursuant to the resolutions of international conferences and annual major sporting events of the International Sport Federation of Firefighters and Rescuers (hereinafter referred to as the Federation), the executive bodies of the Federation have implemented a set of measures aimed at the development and strengthening of fire-rescue sport and joint international activities.

The implementation of the planned activities of the Federation at a professional level took place with the participation of members of committees and commissions, namely: the Executive Directorate, the Ground Jury, the Sports and Technical Committee, the Disciplinary and Anti-Doping Committee, the Sports and Disciplinary Commission and the Audit Commission.

Over the past period 2019-2022, with the support and direct participation of the heads of state fire and rescue services, executive bodies and national public

organizations, the Federation organized and conducted at a highly professional level 6 world championships among men and women, 6 world championships among boys and girls in fire-rescue sport. For the first time in the history of the Federation's development, the World Championship among men and the World Championship among women in fire-rescue sport was held in the Republic of Croatia and the Republic of Uzbekistan, resolution V "On Firefighters and Rescuers Sports" was adopted at the 24th session of the General Assembly of the International Civil Defense Organization on October 14, 2020. It is necessary to note the role of the International Civil Defense Organization in cooperation with the Federation in the field of fire and rescue sports. During this period, the following countries and organizations became full members of the Federation: the Hellenic Republic, the Republic of India, the Italian Republic, the Republic of Cameroon, the State of Qatar, the Kyrgyz Republic, the People's Republic of China, the Republic of Côte d'Ivoire, the Republic of Niger, the Kingdom of Saudi Arabia, the Republic of Senegal, the Republic of Serbia, the Republic of Tajikistan, the Republic of Turkey (city of Istanbul), the Austrian National Association for Fire Sports, the Slovakia Fire Sport Association, associate members – LLC "Ifex Technologies", LLC "Simvent".

During the reporting period, planned international conferences were held, more than 250 delegates, representatives of fire and rescue services, public associations of the member countries of the Federation and invited countries participated in these conferences, 45 resolutions regulating the sports activities of the Federation were adopted. Negotiations were held with representatives of fire and rescue services on their active participation in the Federation's events and entrance to the Federation.

Having listened to and discussed the report on international sports activities and the results of the Federation's work for the period 2019-2022 and in order to determine the main tasks for the period 2023-2026, the XXIII International Conference of International Association "The International Sport Federation of Firefighters and Rescuers" **decided:**

1. To approve the report on the international sports activities and results of the Federation for the period 2019-2022.
2. To recognize the work of the Federation for the period satisfactory.
3. To note the positive dynamics of the growth of the number of sports delegations at the World Championships, the increasing authority of the Federation in the international sports community, improvement in the system of interaction between the governing and executive bodies of the Federation.
4. The executive bodies of the Federation (Executive Directorate, Ground Jury, Sports and Technical Committee, Disciplinary and Anti-Doping Committee, Sports and Disciplinary Commission, Audit Commission) and the member countries of the Federation in their work should be guided by the fundamental documents of the Federation and timely and effectively implement the decisions of the Conference.
5. The organizers and chief judges of international competitions included in the calendar plan of the Federation and held under the auspices of the Federation, should send the following documents to the Executive Directorate at the end of the competition: the report of the chief judge and the minutes of the competition.

6. Participants of world championships, conferences and other international sporting events must comply with the requirements, conditions and deadlines established by the regulatory documents approved by the regular Conference, and promptly send them to the Executive Directorate and organizers of the Federation's events.

7. To achieve the statutory goals of the Federation, the following tasks should be considered as priority ones:

7.1. Consolidation of the international movement and the association of sports organizations developing fire and rescue sport, the admission of new countries (states) and associate members to the Federation.

7.2. Implementation of the Plan of major sporting events of the Federation for 2023-2026, organization and holding of world championships and official international competitions at a high organizational level.

7.3. Development and use of mass media, Internet resources, souvenir and advertising, printed, film, photo and video products for the popularization and promotion of fire and rescue sports at the international level.


8. To inform the members of the International Sport Federation of Firefighters and Rescuers about the inadmissibility of disrupting sports events included in the calendar plan of major sporting events of the International Sport Federation of Firefighters and Rescuers.

9. Instruct the Executive Directorate of the International Sports Federation of Firefighters and Rescuers:

9.1. To work out the issue of holding World Championships in countries that have not previously held championships: the Republic of Austria, the Republic of Azerbaijan, the State of Qatar, the People's Republic of China, Mongolia.

9.2. To continue work on the issue of recognition of the "fire and rescue" sport by the International Olympic Committee.
