REGULATION

on holding the XIII World Championship among boys and juniors and the IX World Championship among girls and juniors in fire and rescue sport "Almaty-2024"

1. Goals and objectives of the competitions

The XIII World Championship among boys and juniors and the IX World Championship among girls and juniors in fire and rescue sport (hereinafter referred to as competitions) are aimed at:

- further international cooperation, development of fire and rescue sport and popularization of the profession of firefighter and rescuer among children and youth;
- attracting young men and women to engage in fire and rescue sport and their participation in international competitions;
- forming an active life position, professional orientation of the younger generation, preservation and strengthening of the health of children, adolescents and youth;
- improving sports skills and physical education of young firefighters and rescuers;
- strengthening friendly ties and exchange of experience in the training of young athletes;
 - preparation of a sports reserve for national sports teams.

2. Organization of competitions

The general management and organization of the competition is carried out by the International Sport Federation of Firefighters and Rescuers in cooperation with the Ministry of Emergency Situations of the Republic of Kazakhstan and the Public Association "Kazakhstan Sport Federation of Firefighters and Rescuers".

The direct organization and conduct of competitions (preparation of competition venues, transfer of the participants from the airport to the hotel and back, medical care, provision of sports and technical equipment, catering and accommodation, cultural and leisure program, media coverage, etc.) is carried out by the Ministry of Emergency Situations of the Republic of Kazakhstan in cooperation with the Akimat of Almaty city and the Ministry of Tourism and Sports of the Republic of Kazakhstan.

The competitions are held in accordance with the rules of competition in fire and rescue sport and the Regulations of international competitions in fire and rescue sport, as amended and modified in 2023.

The fire and technical equipment (with photo), which is used in combat deployment and fire relay race, should be published on the website www.interfiresport.com not later than July 15, 2024.

The competitions in combat deployment are held with the use of the motor pumps of the company «ROSENBAUER FOX III» with STORZ connecting hoses.

3. Dates and venue of the competition

Competitions are held: from 13 to 19 of August 2024. Venue: The Republic of Kazakhstan (Almaty city).

4. Competitors and admission conditions

The competitions are attended by the national teams of boys and girls of the member countries of the International Sport Federation of Firefighters and Rescuers, as well as teams of other countries upon invitation.

The composition of the sports delegation -31 people, of which: the head of the delegation -1; team representative -2; coach (boys, girls) -2, coach-educator (boys, girls) -2; doctor -1, judge -2, press -2; translator -1;

male athletes -9 people: born in 2006-2007 - 3 (juniors), born in 2008-2009 - 3 (middle group), born in 2010 and younger -3 (younger group);

female athletes -9 people: born in 2006-2007 - 3 (juniors), born in 2008-2009 - 3 (middle group), born in 2010 and younger -3 (younger group);

It is allowed to change the quantitative structure of delegation taking into account the declared athletes and the sports personnel.

The President of the national federation of the country participating in the competition has the right to change the composition of the delegation at his discretion.

The representatives of teams need to submit the signed application and passport (or identity card) to credentials committee. Athletes are not allowed to compete without these documents. Applications are submitted separately for the boys' team and the girls' team.

Doping control is carried out during the competition in accordance with the current provisions of the World Anti-Doping Code (WADA), the International Standard for Testing and the Prohibited List. The procedure and number of samples taken from athletes is determined at a joint meeting of representatives of the teams and the Ground Jury on August 14, 2024.

Competitions in climbing the assault ladder, overcoming the 100-meter obstacle course, fire relay and combat deployment are held in two attempts.

7. Procedure and conditions for defining the team and individual championship

The all-team championship among boys and girls is determined by the smallest number of places occupied by teams in all sports disciplines. If the sum of the places is equal, the highest place is awarded to the team with the best result in combat deployment.

The team championship in sports disciplines for boys and girls is determined by the smallest amount of time scored by the scoring participants. If the sum of the amounts of time is equal, teams are awarded the same place (subsequent place is not awarded). The team that has not scored the full number of scoring results is assigned a place after the teams that have a full score. In case of equality of incomplete scores – one should be guided by the smallest amount of time of the scoring participants.

Individual championship in sports events including fire relay and combat deployment for boys and girls is determined according to the best result from two attempts. In case of equal results – according to the best total time of two attempts, and in case of equal amounts of time of two attempts – according to the best result of the first attempt, further – athletes who started earlier.

Final races are held in each age group to determine the winners and prizewinners in climbing the assault ladder and overcoming the 100-meter obstacle course. The number of athletes in the final races is determined by the number of racetracks. The results of the final races are not included in the team result.

The final races are formed according to the results of the preliminary races according to the scheme: 3,1,2,4 result.

The team and individual championships among boys and girls in sports disciplines are held separately.

8. Awarding

The teams that took the 1st, 2nd, 3rd all-team place are awarded with cups and diplomas; participants – with medals and gifts.

Teams that took 1st, 2nd, 3rd place in the fire relay and combat deployment are awarded with cups and diplomas; participants – with medals, diplomas and gifts.

The participants who took 1st, 2nd, 3rd place in the individual championship in climbing the assault ladder, overcoming the 100-meter obstacle course are awarded with medals, diplomas and gifts.

Winners in sports disciplines are awarded with champion ribbons.

Coaches of national teams in all sports disciplines are awarded with medals, diplomas and gifts.

9. Participation conditions of the sports delegations

The annual membership fee of 4,000 (four thousand) US dollars is transferred to the International Sport Federation of Firefighters and Rescuers **before April 1**, 2024.

The participation fee in the amount of 280 (two hundred and eighty) US dollars for one member of the sports delegation is transferred to the account of the host country before August 13, 2024 or on the day of arrival to the competition.

The expenses related to the business trip of sports delegations (travel tickets, accommodation, meals, daily allowances during travel, salary preservation, etc.) are borne by the countries sending the delegation to the competition.

The costs of the competitions are borne by the organizers of the competitions at the expense of their own and attracted funds in accordance with the procedure established by law. The team which failed to pay the membership fee to ISFFR is not allowed to take part in competition (clause 2 of the Regulations).

10. Procedure and deadlines for submitting applications

The preliminary application (official letter) on the participation and the quantitative composition of the sports delegation is sent by June 15, 2024.

The application for the team's participation in competitions in sports disciplines is submitted to the credentials committee on the day of the draw on August 14, 2024.

The registration form of the established sample is sent before July 15, 2024.

This information will be used by the organizers of the event for meeting, organizing the departure, booking hotel rooms, production of accreditation badges and solving other organizational issues.
