RESOLUTION

October 26, 2023

**On the assignment of the sports title
"The Sport Judge of the International Category"
in fire and rescue sport**

Guided by the Regulations on the assignment of the qualification category «The Sport Judge of the International Category» in fire and rescue sport, approved by the Resolution of the XXII International Conference of the International Association "International Sport Federation of Firefighters and Rescuers" dated November 13, 2021 No. 1, taking into account the performance of judicial duties in the composition of the Ground Jury of the world championships and international competitions in fire and rescue sport included in the Plan of main sporting activities of the International Sport Federation of Firefighters and Rescuers, and on the basis of the individual record sheet showing the experience in judging during the competitions, the XXIV International Conference of International Association "International Sport Federation of Firefighters and Rescuers" **decided:**

1. To assign the highest qualification category of sports judges in fire and rescue sport - "The Sport Judge of the International Category" to the following candidates:

- Alexey Vlasov (Russian Federation);
- Mikhail Filatov (Republic of Kazakhstan).

2. To assign as members of the Jury of sports judges of the international category of the International Sport Federation of Firefighters and Rescuers and to hand over the judge's certificate and the judge's badge "The Sport Judge of the International Category" in fire and rescue sport: *Alexey Vlasov, Mikhail Filatov*.

3. The heads of organizations that are part of the International Sport Federation of Firefighters and Rescuers and the Executive Committee of the International Sport Federation of Firefighters and Rescuers, when nominating candidates, keeping records of the record sheet showing the experience in judging during the competitions, and in order to comply with the procedure for issuing certifying documents for the assignment of the qualification judicial category "The Sport Judge of the International Category", should be guided by the Regulations and the Decision of the regular International Conference.

4. The Executive Committee of the International Sport Federation of Firefighters and Rescuers should continue to keep:

- a register of the Jury of Sport Judges of the international category in fire and rescue sport of the International Sport Federation of Firefighters and Rescuers as of January 1, 2024;
- individual record sheets showing the experience in judging during the competitions as part of the Ground Jury of world championships and international competitions in fire and rescue sport.
