RESOLUTION

**On the conduct and results of doping testing of athletes
of the XVIII World Championship among men,
of the IX World Championship among women,
of the XII World Championship among boys and juniors,
of the VIII World Championship among girls and juniors
in fire and rescue sport**

Guided by the provisions of the World Anti-Doping Code (hereinafter referred to as the Code), the International Standard for Testing and Investigations, the International Standard for Therapeutic Use (hereinafter referred to as the Standards), the WADA Prohibited List (hereinafter referred to as the List) and based on the minutes of the meetings of the Disciplinary and Anti-Doping Committee of the International Sport Federation of Firefighters and Rescuers dated August 4, 2023, adopted at the meetings of the Ground Jury of the International Sport Federation of Firefighters and Rescuers, the procedure for conducting of doping testing and the

number of samples of doping testing of athletes of the XII World Championship among boys and juniors and the VIII World Championship among girls and juniors in fire and rescue sport "Saransk - 2023" (Russian Federation) were unanimously determined.

The organizing country, the Russian Federation, announced 6 doping tests.

In the following categories:

"Climbing the assault ladder to the 2nd and the 3rd floors of the training tower" - 4 people (2 samples for boys and juniors and 2 samples for girls and juniors):

- boys and juniors (athletes) who showed two (1,2) best results in preliminary races;

- girls and juniors (athletes) who showed two (1,2) best results in preliminary races.

"Overcoming the 100-meter obstacle course" - 2 people (1 sample for boys and juniors and 1 sample for girls and juniors):

- junior boy (athlete) who showed the best result in the preliminary races;

- junior girl (athlete) who showed the best result in the preliminary races.

Competitive doping testing (biological sampling) in the amount of SIX samples were passed by 6 athletes, including: 3 – athletes (boys and juniors), 3 – athletes (girls and juniors) from the Republic of Belarus – 3, the Russian Federation – 3.

Having heard and discussed the report of the representative of the Disciplinary and Anti-Doping Committee of the International Sport Federation of Firefighters and Rescuers, the XXIV International Conference of International Association "The International Sport Federation of Firefighters and Rescuers" **decided:**

1. To approve the results of the conclusion of the doping testing of athletes of the XII World Championship among boys and juniors and the VIII World Championship among girls and juniors in fire and rescue sport. Doping samples were selected by RUSADA commissioners in accordance with the rules of the World Anti-Doping Agency (WADA). The analysis of the samples was carried out by the Laboratory of the University of Ghent (Belgium), accredited by the World Anti-Doping Agency.

All tested doping samples have a negative result.

2. The fact of non-doping testing of athletes at the XVIII World Championship among men and the IX World Championship among women in fire and rescue sport is considered unacceptable in the future for the organizers of the world championships. To note the incompetence of the representatives of the Republic of Turkey, the organizers at the XVIII World Championship among men and the IX World Championship among women in fire and rescue sport in the matter of doping testing.


3. The Disciplinary Anti-Doping Committee should take control of the organization of doping testing in the countries where the world championships will be held.

4. Consider the prevention of cases of doping in sports as a priority area of sports activity of the International Sport Federation of Firefighters and Rescuers and national organizations of fire and rescue sport.

3. To note the positive and coordinated activities of the members of the Disciplinary and Anti-Doping Committee M. Andrienko and D. Danaev on the organization and conduct of doping control of athletes of the XII World Championship among boys and juniors and the VIII World Championship among girls and juniors in fire and rescue sport at a high professional level.

4. To bring the results of doping testing of the XII World Championship among boys and juniors and the VIII World Championship among girls and juniors in fire and rescue sport to the attention of managers, coaches, medical personnel and athletes of national teams.
