PROVISION

the assignment of qualifying category "International Referee" in Fire and Rescue (Fire-Applied) sport

These Regulations are developed on the basis of the Regulation on the judicial category of "International Judge on fire-rescue sport", approved by the General Meeting of the International Sports Federation of firefighters and rescuers of 16 December 2002 № 1 "On approval of the judicial category of" International Referee in Fire and Rescue sport "and taking into account the amendments to the Rules of competitions in Fire and Rescue (Fire-Applied) sport approved the XV International Conference of the International Sports Federation of firefighters and rescuers in 2015.

1. General Provisions

- 1.1 This Regulation establishes the procedure for assignment of qualification category of the judge and the content of sports qualifications for assignment to the category as well as the rights and duties of the sport referees.
- 1.2. The right to assign the title of "International Referee" in Fire and Rescue (Fire-Applied) sport granted the International Sports Federation of firefighters and rescuers.
- 1.3. The referees of the international category in Fire and Rescue (Fire-Applied) sport may be citizens of countries which are members of the organization Noncommercial Partnership "The International Sport Federation of firefighters and rescuers" and wishing to take part in the judging of international competitions.
- 1.4. The qualification category of "International Referee" in Fire and Rescue (Fire-Applied) sport is awarded for refereeing sports competitions included in the annual plan of the main sports activities of the International Sports Federation of firefighters and rescuers.
- 1.5. The title of "International Referee" is the highest qualification category referees in Fire and Rescue (Fire-Applied) sport.

2. The rights and obligations of the sport referee

- 2.1. Sports referee has the right to:
- in accordance with its qualification category judging competitions in Fire and Rescue sport and have a certificate and a badge "International Referee";
- to carry out judicial seminars and briefings on behalf of international and national federations;
- participate in the training program of educational workshops and certification of tickets, and conduct qualification tests;
- to apply for a duplicate license.
- 2.2. Sport referee must:
- know the rules of the competition in Fire and Rescue (Fire-Applied) sport rules and regulations of the competition in Fire and Rescue sport, meet customer requirements, own method of judging and

correctly apply it in practice;

- to carry out a qualified and impartial judging, eliminating errors that can lead to distortion of competition results, objectively and in a timely manner to address emerging issues in the course of the competition;
- be correcting, courteous and friendly to all the competitors and spectators, facilitate competition in the qualification level:
- to deal with the manifestation of brutality, lack of discipline, violations of the rights of the Rules and Regulations of the competition in Fire and sport by athletes, coaches and representatives;
- improve the level of sports qualification, transfer of knowledge and experience to other judges to work in the promotion of sport;
- to perform judicial duties in the sports referees neat form of the established sample.
- the deprivation of qualification certificate and return a category icon on the Executive Committee ISFFR.
- 2.3. Duties of the sports judges in competitions governed by the rules of competitions in Fire and Rescue (Fire-Applied) sport, depending on the sport from his judicial post sports (functional responsibilities) and to exercise the powers and rights corresponding to these positions.

3. The procedure for assigning qualification category "International Referee"

- 3.1. A candidate for the assignment of category is considered at the next session of the International Conference of the International Sports Federation of firefighters and rescuers.
- 3.2. The decision on the awarding or rejecting the qualification of judicial category of "International Referee" issued Decree Conference.
- 3.3. By the representation (Appendix № 1 to the Regulations) on the assignment of judicial qualification category "International Referee" Supplied with:
- a motion-recommendation (the letter), the organization concerned to submit their nominations to the title:
- information on the implementation of judicial duties in the relevant international competitions;
- size photographs 3x4 cm 3 pieces.
- 3.4. All documents (section 3.3) are sent or transmitted to the Executive Committee of the Federation for further procedure of registration, on the basis of the decision at the next Conference.

4. Requirements for the award of the qualification category "International Referee"

- 4.1. The qualification category of sports judges "International Referee" is assigned to referees who have:
- national (Republican) or the equivalent judging category;
- experience and practice sports refereeing international competition for at least 2 years;
- the practice of sports referee training seminars for judges and other participation in the methodological work.
- 4.2. A candidate for the assignment of the highest qualification category "International Judge" in Fire and Rescue (Fire-Applied) sport referee should have experience taking into account the sports judicial offices of the Main Jury of the competition.
- 4.3. To carry out the duties and powers of judicial office:
- the main international inspectors;
- chief Justice, Deputy Chief Justice;
- chief Secretary, Deputy Chief Secretary;
- major judge in appearance and the judging panel, the Deputy Chief Referee.

- 4.4. The practice of judging for at least 4 international competitions, including the ones not less than 2 World Championships, Europe, Asia, the World Cup and 2 international competitions.
- 4.5. May be replaced with one officiating as Deputy Chief referee of the competition two refereeing in the senior judge officiating team competitions top-level (world championships, European, Asian and international competitions), officiate as a referee-inspector, the commandant are offset more than once.
- 4.6. The judges of the International Sports Federation of firefighters and rescuers may propose a candidate for the title of "International Referee" control refereeing.
- 4.7. The title of "International Referee" is assigned for the judging of the competition if they participated in at least 6 teams.

5. The certificate, badge and sport uniforms

- 5.1. When assigning the judicial ranks and the category "International Referee" in Fire and Rescue (Fire-Applied) sport judgment issued certificate and lapel badge judges of the International Sports Federation of firefighters and rescuers established sample.
- 5.2. Sports uniforms judge advised Competition Rules (3.1.2.) and should be a single sample and color.
- 5.3. Judging certificate and lapel badge referee awarded in a solemn ceremony at the international and national events (republican) level.
- 5.4. Referee badge is worn on the left breast.
- 5.5. The duplicate license issued by the judiciary on the basis of statements by the judge, the tribunal has lost a certificate indicating the circumstances (reasons), the loss of identity of the judiciary.

6. The promotion and disciplinary measures

- 6.1. Promotion of judges and the award of prizes and awards, established by the International Sports Federation of firefighters and rescuers, as well as organizations of the competition may be: departmental awards, diploma, certificate, appreciation, commemorative gift (prize), a cash prize and other types of incentives.
- 6.2. Terms removal of incentives are:
- active and long-standing practice of judicial work perfect;
- flawless performance of judicial duties in the competition;
- significant contribution to the development and popularization of sport;
- disseminating best practices and training of judicial personnel.
- 6.3. At the end of the year The Executive Committee determines the strongest types of judges that can be awarded diplomas or other forms of incentives.
- 6.4. The judges can be applied disciplinary measures in the form of "Note", "Caution", "Disqualification from the competition" the removal from officiating, "Disqualification" with the establishment of its term, "judicial deprivation category."
- 6.5. The conditions of application of disciplinary measures are:
- not performance or improper performance of their duties the sports judge
- violation of the judge specific items competition of rules, have not resulted in serious errors in the

determination of results:

- a gross violation of the judge specific items competition of rules, or which could have led to serious errors in the determination of the results and winners;
- a violation of (a gross violation) norms of behavior and actions of the judge, discrediting the title of judge;
- the presence of repeated notes or warnings.
- 6.6. Disciplinary measures and establishing its validity is determined principally by the international judge inspector of the competition, the Chief Referee of the competition, the Main Jury of the competition (by decision) and the Conference of the International Sports Federation of firefighters and rescuers.

7. Accounting for sports referee activity

- 7.1. Accounting activities sports officiating referees of the international category provides International Sport Federation of firefighters and rescuers, referees jury of national (republic) federations and member organizations of the Federation (National) federations and organizations enters in the ISFFR.
- 7.2. Sports referee activities a sport referee of the international category noted in the ticket and registration card. (Appendix № 2 to the Regulation).
- 7.3. The Executive Committee of the International Sports Federation of firefighter and rescues is the registration form "list of referees of the international category in Fire and Rescue (Fire-Applied) sport considering assigning qualification category" International Referee "re-approved sports referees.
