**Report on the International sports activities
and results of ISFFR for the period 2015-2018
and tasks for the years 2019-2022**

According to the statutory activities of Non-profit partnership «International Sport Federation of Firefighters and Rescuers», pursuant to resolutions of the International Conferences and annual major sporting events of the International Sport Federation of Firefighters and Rescuers (here in after-the Federation), the Executive bodies of the Federation carried out a set of measures aimed at developing and strengthening fire-rescue sports and international cooperative activities.

Direct perpetrator in the implementation of the planned measures Federation for professional work was done by members of committees and commissions: the Executive Committee, the Ground Jury, the Sport and Technical Committee,

the Anti-Doping Disciplinary Committee, the Sport and Disciplinary Commission and the Audit Commission.

Over the past period 2015-2018, with the support and direct participation of the heads of the state fire and rescue services, Executive bodies and national public organizations, the Federation organized and conducted at a highly professional and qualitative level 8 World Championships for men and women, 2 World Championships among national men and women's youth teams, 6 World Championships among boys and girls in fire and rescue sport. For the first time in the history of the Federation, the World Championship among men and the World Championship among women in fire and rescue sports were held in the Slovak Republic, negotiations were held on the recognition of the sport «fire and rescue» by the International Olympic Committee, a number of conditions under which fire and rescue sport can become an Olympic sport, became full members of the Federation of the Republic of Austria, the Republic of Croatia, associate members in 2017-LLC «STA» «Pyrokhimik» in Moscow, in 2018-LLC "SOPOT" in St. Petersburg. The number of participating women's teams has reached 10, which allows us to note the positive dynamics of the development of fire and rescue sports among women, named the names of Champions and World Champions in the sports disciplines of fire and rescue sport, awarded honored sports awards, the number of records increases every year.

During the reporting period, the planned XVI, XVII, XVIII, XIX International Conferences were held, which were attended by 190 delegates and representatives of fire and rescue services and public associations of the Federation member countries and invited countries, 46 resolutions regulating the sports activities of the Federation were adopted. Negotiations were held with representatives of the fire and rescue services on their active participation in the activities of the Federation and their accession to the Federation (Republic of Italy, Republic of Senegal).

After hearing and discussing the report on the international sports activities and results of the Federation for the period 2015-2018 and in order to determine the main aims for the period 2019-2022, XIX International Conference of Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» **has decided:**

1. Report on international sports activities and results of the Federation for the period 2015-2018.

2. To recognize the work of the Federation for the period satisfactory.

3. To note the positive dynamics of growth in the number of women's teams at the World Championships, increasing the authority of the Federation in the international sports community, improving the system of interaction between the governing and Executive bodies of the Federation.

4. Executive bodies of the Federation (the Federation Executive Committee, the Ground Jury, the Sport and Technical Committee, the Anti-Doping Disciplinary Committee, the Sport and disciplinary Commission, the Audit Commission) and member countries of the ISFFR in their work should be guided by the basic

documents of the Federation and in a timely manner and effectively carry out the decisions of the Conference.

5. The organizers and the chief judges of the international competitions included in the schedule of the Federation and held under the auspices of the Federation timely sent to the Executive Committee of the following: provision of the competition, the Ground Jury, the Chief Justice Report and the minutes of the competition.

6. The participants of the World Championships, conferences and other international events to fulfill the requirements, terms and conditions governing the documents approved by the next conference and promptly sent to the address of the Executive Committee of the Federation and organizers of events.

7. In order to achieve the statutory purposes of the Federation considered priorities:

7.1. The consolidation of the international movement and association of sports organizations, cultivating fire and rescue sport, the adoption of new countries (states) and associate members of the Federation.

7.2. The implementation of the Plan of major sporting events in the Federation for 2019-2022, and the organization of the World Championships and the official international competitions at the highest organizational and technical level.

7.3. Develop and use the media, internet resources, souvenirs, advertising, printing, film and photo-video products for the popularization of fire-rescue sport at the international level.

8. To specify the members of the International Sport Federation of Firefighters and Rescuers on the inadmissibility of disrupting sporting events, included in a schedule of major sporting events of the International Sport Federation of Firefighters and Rescuers.

9. To entrust the Executive Committee of the International Sport Federation of Firefighters and Rescuers:


9.1. To study the issue of holding World Championships in countries that were not previously conducting the Championships: Austria, Azerbaijan, Lithuania, Mongolia, Poland, Uzbekistan, Croatia.

9.2. To consider the possibility of recognition International Sport Federation of Firefighters and Rescuers by the Olympic Committee.

10. To establish a working team with the following members for introduction of changes into the current charter of the International Sport Federation of Firefighters and Rescuers: A. Kalinin, Z. Nytra, M. Andrienko, A. Klitonchik, M. Mbaye, N. Rebrova.

11. To create a universal name of the sport's kind - Fire sport - for all member countries of the International Sport Federation of Firefighters and Rescuers.
