**Report about carrying out  
and results of the World Championship  
and working the Ground Jury**

Guided by the Charter of the Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» pursuant to the Plan of the major sporting events of the International Sport Federation of Firefighters and Rescuers for 2018 and regulations the XVIII International Conference of the International Sport Federation of Firefighters and Rescuers from November 15, 2017. № 9 «On approval of the regulations of the world in 2018» and on November 15, 2017 № 10 «On approval of the Ground Jury of the World Championships 2018», according to the provisions of the competitions were organized:



- XIV World Championship among men and V World Championship among women in fire-rescue (fire-applied) sport «Banska Bystrica 2018» (Slovak Republic);
- VIII World Championship among youth and juniors and IV World Championship among girls and juniors in fire-rescue (fire-applied) sport «Varna-2018» (Republic of Bulgaria).

In total in the World Championships participated 41 teams from 15 foreign countries with a total of 394 athletes. New records for a sports discipline were set where female athletes of national teams achieved a significant success.

Training and performance of the judicial duties the judges of the Ground Jury of the world Championships, meet the qualification requirements for judges of sports competitions of international level.

After hearing and discussing the report of Chief Justices of the World Championship in fire-rescue sport, held in 2018, XIX International Conference of Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» **has decided:**

1. To consider the performance of the decision of the XVIII International Conference of the International Sport Federation of Firefighters and Rescuers of the World Championship in 2018 in a professional and organizational level.

2. To recognize the work of referees in the compositions of the Ground Jury of the World Championships in 2018 performed at a good level and in accordance with the qualification requirements and judging category referees.

3. The Main Referee of the World Championship to perform the duties in terms of the preparation and submission of the report the main referee on completion of the competition, according to the rules of the competition on fire-rescue (fire-applied) sports Art. 3.3.2 and application number 17 to the Regulation.

4. The Chief Secretary of the World Championship to serve as part of the preparation and presentation of certificate of registration record on completion of the competition, according to the rules of the competition on fire-rescue (fire-applied) sports Art. 3.7.1 application number 16 to the Regulation.

5. To form the compositions of the Ground Jury and the judging panel of the World Championships in 2019 in view of increasing the number of participants.

6. Specify the countries conducting the World Championships:

6.1. About the necessity of testing sleeves for combat deployment and the timely execution and provision of reports to the Ground Jury.

6.2. About the order of the award ceremony and prize fund according to regulations on competitions.

7. To Express gratitude to General A. Nejedly - President of the International Sport Federation of Firefighters and Rescuers of the Ministry of Internal Affairs of the Slovak Republic for the first time conducting the World Championship among men and women in fire and rescue sports at a high professional and organizational level.
