About assignment of sports ranks «International Judge» in fire-rescue (fire-applied) sport

Guided by the Regulation on the qualification category «International Judge» in fire and rescue (fire-applied) sport, approved by Resolution of the XVI International Conference of Non-profitPartnership «The International Sport Federation of Firefighters and Rescuers» from November 19, 2015 No. 14, subject to the execution of judicial duties in the compositions of the main jury of the World Championships and international competitions in fire and rescue (fire-applied) sport, included in the annual Plan of major sports events ISFFR and on the basis of individual record cards of the practice of judging the competition, XIX International conference of the Non-profit Partnership «The International Sport

International conference of the Non-profit Partnership «The International Sport Federation of Firefighters and Rescuers» has decided:

- 1. Assign the highest qualification category of sports judges in fire and rescue (fire-applied) «International Judge» the following nominees:
 - AbolinsOskars (Republic of Latvia);
 - Lavetsky Shimon (Republic of Poland);
 - Orynbayev Saken (Republic of Kazakhstan);
 - Uschapivsky Igor (Ukraine);
 - Nikolaev Nikolay (Republic of Bulgaria).
- 2. To enroll in the composition of the Board of referees of the international category of the International Sport Federation of Firefighters and Rescuers, and to present judicial identity and judicial lapel badge «International Judge» in fire and rescue (fire-applied) sport: O. Abolins, S. Lavetsky, S. Orenbaev, I. Uschapivsky, N. Nikolaev.
- 3. The heads of organizations, members of the International Sport Federation of Firefighters and Rescuers and the Executive Committee of the Federation in case of nominating candidates, the conduct of registration cards practices of refereeing and referees in order to comply with the registration procedure of the certifying documents for the qualification of the officiating category of «International Judge» to be guided by the Provision and the Decision of the next International Conference.
