About powers and composition of governing bodies, Executive and Supervisory committees and commissions

For the further implementation of the activities of the Federation and pursuant to the paragraphs 6.1, 7.2, 7.13, 7.16, 7.17, 7.21-7.24, 10.1, and also in connection with the expiration of term of office of the President of the International Sport Federation of Firefighters and Rescuers V.A. Puchkov, the XIX International Conference of Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» has decided:

1. To elect the President of the International sport Federation of Firefighters and Rescuers Alexander Petrovich Chupriyan for a period of four years.

- 2. For carrying out current management, the organization of implementation of resolutions of Conference, the President, the highest collegial body and resolutions of other issues with in the competence and the Charter of Federation elect the Director of Executive Committee of the International Sport Federation of Firefighters and Rescuers Andrey Petrovich Kalinin for a period of four years.
- 3. For control of financial and economic activity of the International Sport Federation of Firefighters and Rescuers elect the Auditing Commission (AC) of the International Sport Federation of Firefighters and Rescuers consisting of 3 people. The Chairman of the Auditing Commission is Andrienko Margarita (Republic of Belarus), members of the Commission are Nytra Zdenek (Czech Republic), Danaev Dauren (Republic of Kazakhstan).
- 4. For the purpose of improvement of rules of competitions in fire and rescue (fire and applied) sports of the International Sport Federation of Firefighters and Rescuers, Regulations of carrying out competitions, elect the Chairman of Sport Technical Committee (STC) of the International Sport Federation of Firefighters and Rescuers Klitonchik Alexander (Republic of Latvia), members (STC): Lefner Tomas (Czech Republic), Dudonov Yuri (Russian Federation), Suponenko Vladimir (Republic of Belarus), Danaev Dauren (Republic of Kazakhstan), Kalinowski Piotr (Republic of Poland), Surzhin Vladimir (Slovak Republic), Merenkov Vitaly (Ukraine), Bastish Hartmut (Germany).
- 5. For the purpose of coordination, effective interaction at the international level and implementation of the anti-doping policy aimed at prevention of doping, elect the Chairman of the Disciplinary Anti-Doping Committee (DAC) of the International Sport Federation of Firefighters and Rescuers Nytra Zdenek (Czech Republic), members of the DAC: Andrienko Margarita (Republic of Belarus), Vetuh Vladimir (Republic of Latvia), Bastish Benny (Germany), Starygin Vladimir (Russian Federation), Kapusniak Jaroslav (Slovak Republic).
- 6. For the purpose of implementation of control and disciplinary functions, consideration and the resolutions of issues of disciplinary appointment and ensuring high sports level of competitions, elect the Chairman of the Sport and Disciplinary Commission (SDC) of the International Sport Federation of Firefighters and Rescuers Rebrova Natalia (the Russian Federation).

Members of SDC are elected at the next World Championship during the meeting ofthe Ground Jury.
