**About qualification training  
the judicial system and conduct  
educational seminars**

Pursuant to the Resolution of the XVI International Conference of Non-Profit Partnership «The International Sports Federation of firefighters and rescuers» from November 19, 2015 № 6 «On conducting training and methodological seminar on the training (retraining) of the judicial apparatus World Championship in Fire and Rescue Sport» and to form Officials for the service of the world championships qualified sports judges were organized and conducted training and methodological seminars and classes on theoretical and practical training, in accordance with the rules of the competition on fire-rescue (fire-applied) sport.

Having heard and discussed the information provided and taking into account the annual increase in the number of participating teams and athletes of different age groups and categories in the World Championships, XVII International Conference of Non-Profit Partnership «The International Sports Federation of firefighters and rescuers» **has decided:**

1. The organizers of the world championships in 2017 to recommend the holding of seminars and training for qualification training referees to form the judging panel for the fire-rescue sport.

2. To instruct the Executive Committee of the International Sports Federation of firefighters and rescuers, and the judges of the international category provide practical assistance to the organizers of the world championships in conducting training seminars for training and qualification of judges and court sports.

3. Include a major sporting event of the International Sports Federation of firefighters and rescuers for 2017 holding educational seminars at the venue of the world championships.

4. Hold competitions in accordance with Rules of competitions on fire-rescue (fire-applied) sport of the International sports federation of firefighters and rescuers.
