On Approval of the Sports and Disciplinary Commission

Guided by the Charter of the Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers», pursuant to the XVII International Conference of «The International Sport Federation of Firefighters and Rescuers» from November 26, 2016 № 11 with amendments and additions at the meeting of the Ground Jury and team representatives of the XIII World Championship among men and IV World Championship among women in fire and rescue (fire-applied) sport «Izmir-2017» September 26, 2017 elected Sports disciplinary Commission: D. Danayev (Kazakhstan), A. Dugalur (Turkish Republic), V. Nemilov (Republic of Belarus), A. Dovgalevez (Republic of Belarus) and V.Starygin (Russian Federation) for the implementation in the framework of their powers control and disciplinary functions in respect of sports discipline and sports ethics, the enforcement of the

governing documents of the Federation and regulations about the competition participants of the World Championships.

Having heard and discussed the report, subject to a positive assessment of the ethical environment in competitive and out-of-competition periods for World Championships and the suggestions made, the XVIII International Conference of the Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» has decided:

- 1. To consider the respect for sports ethics participants the determining factor of the level of organization XIII World Championship among men and IV World Championship among women in fire and rescue (fire-applied) sport «Izmir-2017» with the following indicators:
- the absence of a written (oral) applications, complaints and other allegations of disciplinary violations committed by participants during the World Championships;
- timely execution of requirements and instructions emanating from the Ground Jury, members of committees, commissions and heads of delegations in compliance with the principles of subordination and relationships in the field of sports activities.
- adoption of constructive solutions in the framework of professional competence and qualification of the sports office in the event of difficult sporting situations and disagreements.
- 2. Positive work of leaders and coaching staffs of sports delegations for the work done in sport, ethical and moral education of athletes based on the principles of respect, loyalty, tolerance, moral and volitional qualities of each athlete.
