**About assignment of sports ranks  
«International Judge» in  
fire-rescue (fire-applied) sport**

Guided by the Regulation on the qualification category «International Judge» in fire and rescue (fire-applied) sport, approved by Resolution of the XVI International Conference of Non-profit Partnership «The International Sport Federation of Firefighters and Rescuers» from November 19, 2015 No. 14, subject to the execution of judicial duties in the compositions of the main jury of the World Championships and international competitions in fire and rescue (fire-applied) sport, included in the annual Plan of major sports events ISFFRS and on the basis of individual record cards of the practice of judging the competition, XVIII International conference of the Non-profit Partnership «The International Sport Federation of Firefighters and Rescuers» **has decided:**



1. Assign the highest qualification category of sports judges in fire and rescue (fire-applied) «International Referee» the following nominees:

- Andrienko Margarita (Republic of Belarus);
- Derse Ismail (Turkish Republic);
- Maha Roman (Czech Republic);
- Sukhorukov Victor (Russian Federation);
- Jaluvka Zdenek (Czech Republic).

2. To assign the highest qualification category of the sports judge "Judge of the international category" in fire and rescue (fire-applied) sport to the judges of the national category: Buzko Valentin, Budnik Alexander, Lasch Viktor, Petruk Nikolai, Sas Vitaly and Ancho Shishkov, when presented to the Executive Committee of the ISFFR personal submissions in accordance with the established form for the assignment of the RIC qualification category from the Federation of Fire and Applied Sport of Ukraine and the Bulgarian Federation of Fire and Applied Sport.

3. To enroll in the composition of the Board of referees of the international category of the International Sport Federation of Firefighters and Rescuers: M. Andrienko, I. Derse, R. Maha, V. Sukhorukov, Z. Jaluvka, V. Buzko, A. Budnik, V. Lasch, N. Petruk, V. Sas and A. Shishkov, to present judicial identity and judicial lapel badge «International Judge» in fire and rescue (fire-applied) sport.

4. The heads of organizations, members of the International Sport Federation of Firefighters and Rescuers and the Executive Committee of the Federation in case of nominating candidates, the conduct of registration cards practices of refereeing and referees in order to comply with the registration procedure of the certifying documents for the qualification of the officiating category of «International Referee» to be guided by the Provision and the Decision of the next International Conference.

5. To instruct the Executive Committee of the International Sport Federation of Firefighters and Rescuers:

- Continue the maintenance of the Register of sports referees of international category on fire-rescue sport from January 1, 2018;

- Continue to maintain an individual registration card practices officiating referees in the compositions of the Ground Jury world championships and international competitions.
