Approval dimensions of contributions for 2017 and terms of payment

According to paragraph 1.1. 11.5-11.8 of the Charter of Non-Profit Partnership "The International Sport Federation of firefighters and rescuers' Federation property is based on contributions from its members. Earmarked contributions for the financing of specific sporting events, entry and membership fees are directed to the maintenance of authorized activity and the content of the Federation. The amount of entry and annual membership fees that make up the budget of the Federation and target fees are set and approved by the Resolution of the Conference.

Having heard and discussed the report of the bids received, XVII International Conference of Non-Profit Partnership «The International Sport Federation of firefighters and rescuers» has decided:

1. To approve the entry fee of a candidate country for membership of the Federation in the amount of 5000(five thousand) US dollars.

The country which has paid the entry fee in the current year shall be exempt from paying the membership fee.

- 2. To approve the annual membership fee of members of the Federation in the amount of 3300 (three thousand three hundred) US dollars.
 - 3. To approve the participation fee amounts:
- 3.1. At the world Championships among boys, girls and youth teams of 150 (one hundred fifty) US dollars per one participant of the sports delegation.
- 3.2. At the world Championships for men and women 180 (one hundred eighty) US dollars per one participant of the sports delegation.
- 4. The quantitative structure of sports delegation and the procedure for payment of the fee of the target established by the decision of the Conference and is brought into position to hold the World Cup.
- 5. Country-organizers of the world championships are exempt from paying the annual membership fee.
- 6. The heads of national federations, associations and other institutions that are members of the Federation to provide an annual payment of membership dues to April 1 of the year.
 - 7. To approve the breakdown of the budget expenses Federation for 2017.
- 8. To amend the charter in the part relating to the status of the Director of the Executive Committee of the Federation. Before making any changes to the Charter establish a monthly financial incentives the Director of the Executive Committee in accordance with clause 11.10 of the Charter.
